Investment Objective

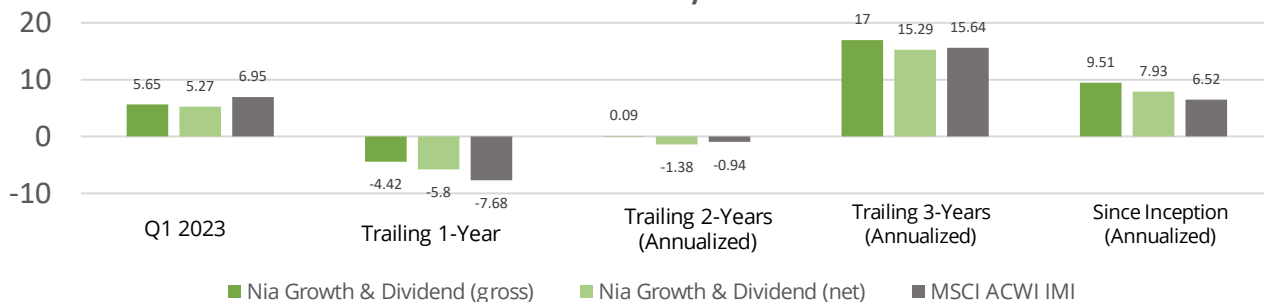

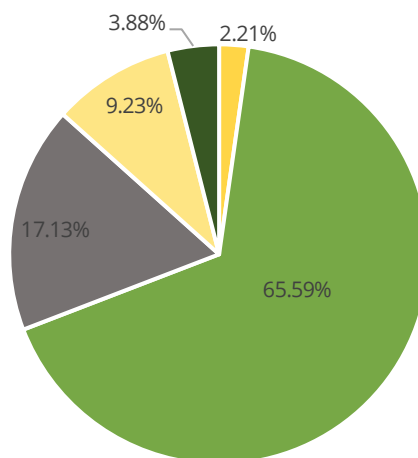
